

## NOTICE OF OFFICES TO BE ELECTED

I, Sasha N. Habe, Sherman County Election Commissioner, hereby give notice of the offices to be filled by election that will appear on the 2026 Election Ballot in Sherman County Nebraska. Notice is also given that the filing deadlines for candidates nominated in the **Primary Election** are:

**February 17, 2026, by 5:00p.m. for incumbents.**  
**March 2, 2026, by 5:00p.m. for non-incumbents.**

Notice is also given that filing deadlines for the **General Election** are:

**July 15, 2026, by 5:00p.m. for incumbents.**  
**August 3, 2026 by 5:00p.m. for non-incumbents.**

### **Primary Election - May 12th, 2026**

### **General Election - November 3rd, 2026**

In compliance with Section 32-811, if the names of candidates properly filed for nomination at the primary election for directors of natural resources districts, public power districts, reclamation districts, members of the boards of community colleges, Class III school districts which nominate candidates at the primary election, cities of the second class and political party county officers do not exceed two candidates for each position filled, any such candidate shall be declared nominated and their names shall not appear on any primary election ballots.

The election commissioner shall place the names of such automatically nominated candidates on the general election ballots as provided. **Dated this 16th day of January, 2026**
