**Sherman County Board of Commissioners**

The Sherman County Board of Commissioners met in regular session on Tuesday, December 23, 2025, in the Boardroom of the Sherman County Courthouse with the following persons present: Tom Bandur-Chairman and David Siegel. Absent, Kenneth Kaslon-Vice Chairman. Also, present was Marcy Sekutera- Sherman County Clerk and Sasha N. Habe-Sherman County Deputy Clerk. The Chairman called the meeting to order at 9:00a.m. Notice of the meeting was published in the Sherman County Times and given in advance to all members of the Board. At the beginning of the meeting, the Chairman announced and informed the public that a current copy of the Open Meeting Act was posted on the South wall of the Boardroom with copies of the Act also available in the Boardroom for public viewing.
