At the beginning of the meeting, the Chairman announced and informed the public that a current copy of the Open Meeting Act was posted on the South wall of the Boardroom with copies of the Act also available in pamphlet form in the Boardroom for viewing.

The County Board may postpone or change regular meeting dates when necessary to accommodate seminars, meetings or for other purposes the Board deems necessary. Meeting notices to be published in the Sherman County Times the week before the meeting and on the County's current internet site at https://shermancounty.nebraska.gov the County will use its best efforts to post notices of public meetings by this method. For special or regular meeting notices, when publication is not available, notice may be given by posting notice in three locations in the county at least two days prior to the scheduled meeting. - Motion by Griffith and seconded by Bandur that persons check with the Clerk of the District Court and Clerk Magistrate as to when the courtroom may be used for special meetings. Roll Call Vote: Ayes: All. Motion carried.
- Motion by Bandur and seconded by Kaslon to have the Sherman County Treasurer advertise and offer for sale at Public Tax Sale for the tax year 2020 and any previous years when the same remains unsold for want of bidders on real estate where taxes are unpaid. Roll Call Vote: Ayes: All. Motion carried.
- Motion by Bandur and seconded by Griffith to designate Ashton State Bank, Citizens Bank, Heritage Bank, Town & Country Bank, Union Bank & Trust, NFIT and NPAIT as legal depositories for 2022, that County funds deposited in such depositories shall be deposited on a pro-rate as set forth in Section 77-2314 of the Nebraska Statutes; and that the Sherman County Treasurer is authorized to invest idle funds as she sees fit.
